<b>Withdrawals<sup>5,7</sup> (Partial Withdrawals)</b>	<ul style="list-style-type: none"> <li>Allowed after 5th policy year, a partial withdrawal of the cash value will result in a proportional reduction of accumulation value, specified amount, and Continuation Guarantee account values</li> <li>Death benefit cannot be reduced below \$90,000 as a result of the withdrawal, \$45,000 for New York</li> <li>Current charge of \$25 for each withdrawal (maximum contractual charge of \$50 for each withdrawal)</li> </ul>

## AVAILABLE RIDERS<sup>8</sup> and OPTIONS

<b>Accidental Death Benefit</b>	<ul style="list-style-type: none"> <li>Provides an additional death benefit if death is accidental</li> <li>Double Accidental Death Benefit is paid if the death is sustained while a fare-paying passenger on a licensed public conveyance</li> <li>Minimum: \$25,000/Maximum: The lesser of \$250,000 or the initial sum insured under the policy</li> </ul>
<b>Children's Insurance Benefit Rider</b>	<ul style="list-style-type: none"> <li>Provides term insurance on the base insured's dependent children—up to but not including age 25</li> <li>Minimum: \$1,000/Maximum: \$25,000</li> </ul>
<b>Enhanced Surrender Value Rider</b>	<ul style="list-style-type: none"> <li>Return of premium rider provides a one-time option for surrender, during the 60-day period following the end of policy years 20 or 25</li> <li>The amount of cash surrender value is 50% of the total premium paid at the end of year 20, or 100% of total premium paid at the end of year 25, net of partial withdrawals and outstanding loans. These benefits are capped at 40% of the lowest Specified Amount in the policy. See the Rider for details.</li> </ul>
<b>Accelerated Access Solution<sup>®</sup></b>	<ul style="list-style-type: none"> <li>Premium paying rider provides income for qualifying chronic condition.</li> <li>Three benefit options available including an IRS maximum per diem amount which provides a form of inflation protection for the policy owner's benefit.<sup>9</sup> Monthly benefit is capped at the maximum IRS daily rate at the time of claim. <ul style="list-style-type: none"> <li>The 2020 maximum per diem is \$380/day or \$11,558/month. Subsequent years may be higher.</li> <li>2% of AAS benefit per month</li> <li>4% of the AAS benefit per month</li> </ul> </li> <li>This rider must be issued in conjunction with the Terminal Illness rider in states where both are approved.</li> </ul>
<b>Lifestyle Income Solution<sup>®</sup></b>	<ul style="list-style-type: none"> <li>Premium-paying rider provides guaranteed withdrawal benefits (regardless of cash surrender value under the policy)</li> <li>Begins on the initial election date for withdrawal benefits and on each month thereafter</li> <li>Minimum specified amount \$64,241<sup>10</sup></li> <li>Maximum specified amount \$10,000,000 (Assuming no other coverage in force)</li> <li>Minimum eligibility period for the rider is 15 years</li> </ul>
<b>Terminal Illness Rider</b>	<ul style="list-style-type: none"> <li>Provides an accelerated death benefit (living benefit) when the insured is diagnosed with a terminal illness (24 months or less to live)</li> <li>One-time acceleration benefit of up to 50% of the base policy death benefit (less policy loans and excluding riders)</li> <li>Maximum: \$250,000</li> <li>Subject to an administrative fee</li> <li>Some states require a signed disclosure form at time of application</li> </ul>
<b>Waiver of Monthly Deduction Rider</b>	<ul style="list-style-type: none"> <li>Waives the monthly deduction while the insured is disabled after six months of disability</li> <li>Premiums are based on the insured's attained age</li> <li>Rider not available for face amounts greater than \$5 million</li> </ul>

### IMPORTANT CONSUMER DISCLOSURES REGARDING ACCELERATED BENEFIT RIDERS

An Accelerated Death Benefit Rider (ABR) is not a replacement for Long Term Care Insurance (LTCI). It is a life insurance benefit that gives you the option to accelerate some of the death benefit in the event the insured meets the criteria for a qualifying event described in the policy. The rider does not provide long-term care insurance subject to California insurance law, is not a California Partnership for Long-Term Care program policy. The policy is not a Medicare supplement.

ABRs and LTCI provide different types of benefits. An ABR allows the insured to access a portion of the life insurance policy's death benefit while living. ABR payments are unrestricted and may be used for any purpose. LTCI provides reimbursement for necessary care received due to the inability to perform activities of daily living or severe cognitive impairment. LTCI coverage may include reimbursement for the cost of a nursing home, assisted living, home health care, homemaker services, adult day care, hospice services or respite care for the primary caretaker and the benefits may be conditioned on certain requirements or meeting an elimination period or limited by type of service, the number of days or a maximum dollar limit. Some ABRs and all LTCI are conditioned upon the insured not being able to perform two or more of the activities of daily living or being severely cognitively impaired.

This ABR pays proceeds that are intended to qualify for favorable tax treatment under section 101(g) of the Federal Internal Revenue Code. The federal, state, or local tax consequences resulting from payment of an ABR will depend on the specific facts and circumstances, and consequently advice and guidance should be obtained from a personal tax advisor prior to the receipt of any payments. ABR payments may affect eligibility for, or amounts of, Medicaid or other benefits provided by federal, state, or local government. Death benefits and policy values, such as cash values, premium payments and cost of insurance charges if applicable, will be reduced if an ABR payment is made. ABR payments may be limited by the contract or by outstanding policy loans.
